Student Government Initiative on Sweat-Free Tee-Shirt Purchases

USG has put together an ad hoc committee to review all of USG's rules and regulations. This committee has not met yet, but they hope to meet bi-weekly and this item is something that this committee can work on. John and USG will work to put legislation forward on sweat-free tee-shirt purchases.

Even if USG moves forward with this, the University is still all over the map with purchases. We need to get consistency on campus for logos, etc. Once we have the model from USG, this Committee will need to develop a set of recommendations for the University. Tim Tolokan will look into developing a list that we can send out to contract vendors.

DSP Update

College Bookstore Letter Julie sent out the College Bookstore letter to the group in December for review. This letter raises a number of issues that might come up. Julie will resend the letter to the Committee to review.

El Salvador

Julie distributed a schedule for the Working Group's possible trip to an apparel producing country to visit factories and meet with garment workers. This Committee has some concerns about this sort of trip. Because we wanted to be clearer about the possibility of this trip, Julie distributed the information and schedule on this trip. Julie talked with Ron Schurin in the President's Office about this and he asked for the committee to make a recommendation to the President about participation with this trip. Dr. Saddlemire, Vice President for Student Affairs, has also offered his support of a student going on this trip.
